## **I. REQUIREMENTS TO BE A SETTLEMENT CLASS MEMBER**

For you to be eligible for benefits, you must be a member of the Settlement Class and file a valid Claim Form. The Settlement Class is defined as:

All persons in the Commonwealth of Pennsylvania who were enrolled as a customer of Defendants and were on Defendants' Variable Rate Electricity Plan at any time between June 1, 2011 and May 31, 2018.

The term "Variable Rate Electricity Plan" means any and all variable rate electricity plans that were offered by Defendants to residential customers in Pennsylvania.

You are not a Settlement Class Member, even if you meet the above criteria, if:

- You are the judge to whom this Action is assigned or any member of the judge's immediate family;
- You are one of the lawyers in this Action or a member of any of their immediate families; or
- You previously released claims against Defendants, including but not limited to persons who released claims against Defendants pursuant to the settlement of a complaint submitted to the Pennsylvania Public Utility Commission.

## **II. GENERAL INSTRUCTIONS**

Read all instructions below before filling out the Claim Form.

If you intend to submit your Claim Form by mail:

1. Type or print legibly all information in blue or black ink.
2. Sign and date the Claim Form under Part 2. **Your claim will not be processed if your Claim Form has not been signed and dated.**
3. Make a copy of your completed Claim Form for your records. Then sign the form and mail it to:

To be considered timely, your Claim Form must be submitted online or mailed and postmarked by no later than **November 30, 2018**. Failure to submit your claim by this deadline will result in the denial of your claim.

No acknowledgement will be made as to the receipt of your claim, except as follows. You will receive a rejection letter if your claim is invalid; and you will receive a deficiency letter if your claim is deficient in ways that you can correct. If your claim is valid, you will be sent a check. If you want further confirmation that your claim was received, please send it via Certified Mail, return receipt requested.

## **III. SETTLEMENT BENEFITS**

To receive any benefits pursuant to the Settlement, you must be a Settlement Class member who timely submits a valid Claim Form.

The following benefits are available to Settlement Class members who submit a timely and valid Claim Form:

A Settling Class member who was on Stream's Variable Rate Plan at any point between June 1, 2011 and February 28, 2015 (Time Period 1) will receive payment in the amount of 5% of all amounts he or she paid to Stream for service provided under the Variable Rate Plan during Time Period 1.

A Settling Class member who was on Stream's Variable Rate Plan at any point between March 1, 2015 and May 31, 2018 (Time Period 2) will receive payment in the amount of 2% of all amounts he or she paid to Stream for service provided under the Variable Rate Plan during Time Period 2.
